



## To the Honorable Court and Presiding Probation Officers:

This packet certifies that the defendant is enrolling in a federally recognized, ADA-compliant online alternative sentencing program administered directly by **The Foundation of Change**, a Section 501(c)(3) public charity.

Unlike instant-completion "certificate mills" operated by unverified entities, our restorative justice curriculum utilizes strict architectural compliance mechanisms to ensure bona fide engagement. Every certified hour submitted to your court enforces the following restrictions:

- 1. Identity & Court Verification:** At enrollment, all participant data is permanently tied to their verified identity, home address, and contact information to prevent identity swapping.
- 2. Window Blur & Tab Visibility:** Active engagement is mandatory. Our environment actively monitors browser focus, immediately pausing the time-tracker if a participant minimizes the window or alt-tabs to a different tab, coupled with a strict 10-minute AFK timeout.
- 3. Multi-Tab Blocks & Daily Caps:** Our platform utilizes override protocols to prohibit users from opening multiple coursework tabs simultaneously, and enforces an 8-hour maximum daily throttle to eliminate artificial "speed-running".
- 4. Time-Locked & Qualitative Assessments:** Reflection text forms remain physically locked until the individual spends the analytically required reading time for each module. We enforce strict character-count minimums and actively disable clipboard copy/pasting to verify genuine cognitive engagement.

### THE VERIFICATION PORTAL

We operate as an accountability partner to the justice system. We do not ask the court to blindly trust a printed certificate. Any judge, district attorney, or probation officer may visit [thefoundationofchange.org/certificate-verification](http://thefoundationofchange.org/certificate-verification) to securely pull the raw, server-side Hour Logs—confirming exact localized timestamps and completion records for this specific client.

We remain at the disposal of the court to provide any necessary programmatic data or programmatic audits required to validate a participant's hours.

# Official Enrollment Instructions

You have been directed by your attorney to complete your court-mandated community service hours through The Foundation of Change. Because this is a verified 501(c)(3) platform that utilizes architectural engagement tracking, your progress will be audited by the court.

**Do not attempt to cheat or skip modules, as your attorney and the court will be notified of invalid submissions.**

## Step-by-Step Enrollment

---

### **STEP 1: VISIT THE REGISTRATION PORTAL**

Go to [thefoundationofchange.org/start-now](https://thefoundationofchange.org/start-now) on any computer, tablet, or smartphone.

### **STEP 2: SELECT YOUR COURT REQUIREMENT**

Choose the specific tier of hours ordered by the judge (e.g., 20 Hour Program, 40 Hour Program). Do not select fewer hours than you were mandated.

### **STEP 3: ENTER YOUR COURT DATA**

You will be prompted to create your verified account profile using your full legal name and address. *Entering this data correctly is critical for your final Certificate of Completion.*

### **STEP 4: BEGIN YOUR COURSEWORK**

You may begin immediately upon enrollment. Your digital progress is automatically saved to our secure servers if you need to log out and continue later.

#### **STRICT COMPLIANCE NOTICE:**

If you leave your browser open and walk away from your device, your tracker will automatically pause after 10 minutes. You must complete the written assessments yourself. Copying and pasting text will result in your hours being flagged.
